### **Extinguishment Order 2025**

This Order is made by the Secretary of State for Environment, Food and Rural Affairs ("the Secretary of State") under sections 118A and 120(3A) of the Highways Act 1980.

The footpath described in paragraph 1 of this Order crosses a railway otherwise than by a tunnel or bridge.

It appears to the Secretary of State that it is expedient in the interests of the safety of members of the public using, or likely to use, the said unrecorded footpath that it should be stopped up.

THIS ORDER EXTINGUISHES the public right of way over the land situate at Bailey Lane Level Crossing in the Parish of Grange-over-Sands in the County of Westmorland and Furness shown by a continuous bold line on the map attached to this order and described in the schedule after X days from the date of confirmation of this Order. 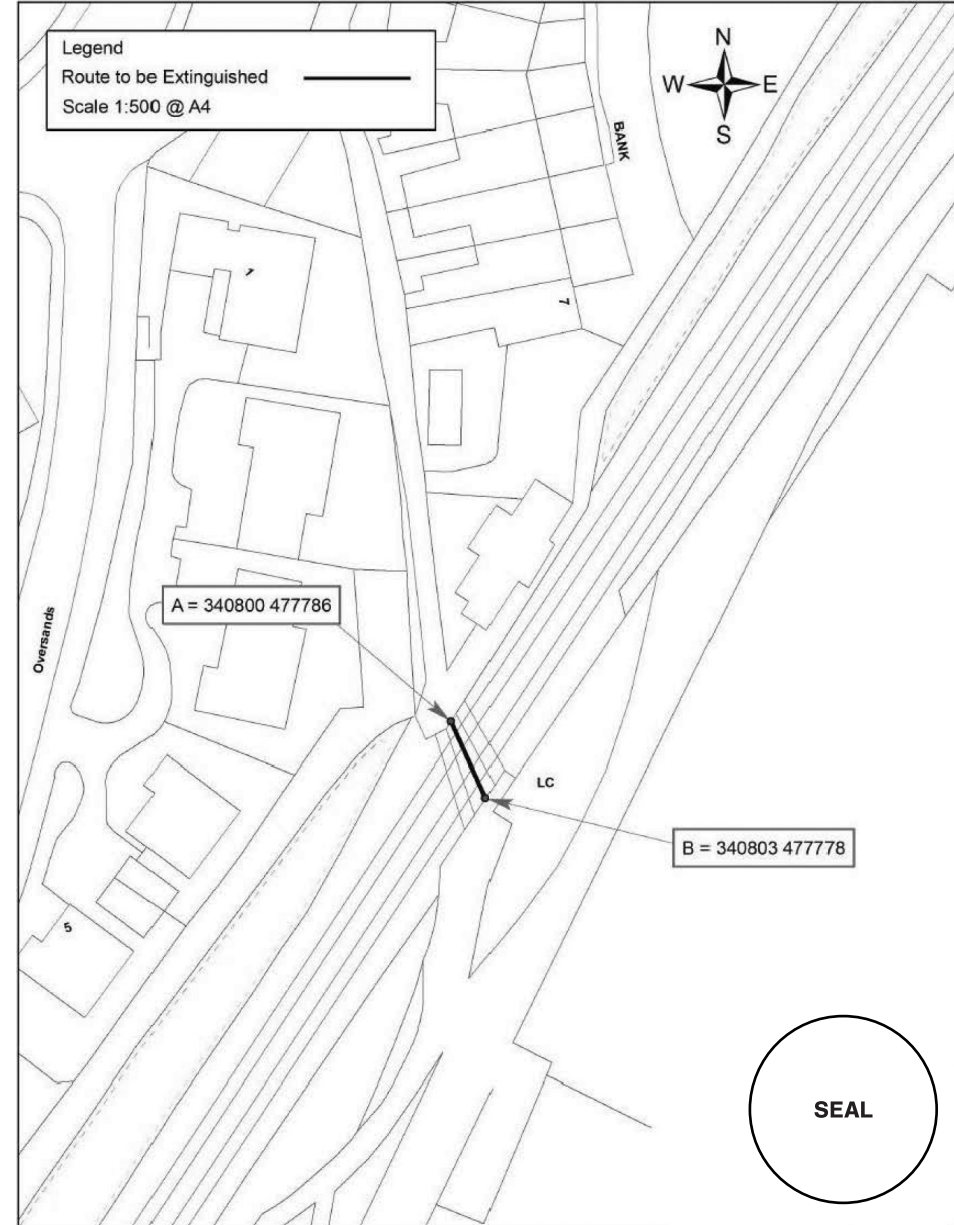
