

**THE CITY OF EDINBURGH COUNCIL**

**(TRAFFIC REGULATION: RESTRICTIONS ON WAITING, LOADING AND UNLOADING, STOPPING AND PARKING PLACES) (VARIATION NO \_) ORDER 202\_ - TRO/24/32**

The Council proposes to make an Order under the Road Traffic Regulation Act 1984 as amended to: (a) introduce permit holders parking places and/or shared use parking places on Easter Dalry Dr, Easter Dalry Rd & Easter Dalry Wynd; (b) introduce and/or extend 24hr waiting restrictions on Easter Dalry Dr, Easter Dalry Rd & Easter Dalry Wynd; (c) introduce bicycle hanger parking place on Easter Dalry Rd; (d) extend waiting restrictions and loading prohibitions on Easter Dalry Rd; & (e) introduce permit eligibility for residents of Easter Dalry Dr, Easter Dalry Rd & Easter Dalry Wynd within Controlled Parking Zone S4 for (Mon-Fri between 08:30-17:30). Residents will be entitled to purchase two residential permits per household. The cost of a resident parking permit will be as follows. Vehicles registered prior to March 2001 will have charges applied in relation to engine size. Vehicles registered after March 2001 will have charges applied in relation to CO2 emissions.
