(A904 FALKIRK ROAD, GRANGEMOUTH)

(TEMPORARY PROHIBITION OF TRAFFIC)

(NO.TTRO/1996) ORDER 2026

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on A904 Falkirk Road from Earlsgate Roundabout to Laurieston Road westbound only from 20.00 hours to 06.00 hours in consecutive dates between 27/07/2026 to 30/07/2026. The prohibition is to allow for carriageway surfacing operations in a safe manner.

(TEMPORARY PROHIBITION OF TRAFFIC)

(NO.TTRO/1997) ORDER 2026

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on Stadium Way, Grangemouth from the junction of the A904 Falkirk Road, south-eastwards for 65 metres from 01/08/2026 to 21/08/2026 except football matchdays and any other event at Falkirk Stadium. The prohibition is to allow for the upgrading of the junction and surrounding infrastructure.

(NO.TTRO/1998) ORDER 2026

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on Alexander Avenue, Falkirk from the junction of the A904 Grangemouth Road, south for 10 metres from 31/07/2026 to 21/08/2026. The prohibition is to allow for the upgrading of the junction and surrounding infrastructure.
