Members’ Allowances Scheme For Bedfordshire Fire and Rescue Authority

In accordance with the requirements of the Local Authorities (Members’ Allowances) (England) Regulations 2003. Bedfordshire Fire and Rescue Authority has made a Members’ allowances scheme to take effect for the period from 1 April 2026 until 31 March 2027, having had regard to the recommendations of the Independent Remuneration Panels of its three constituent councils. The Scheme permits the payment of the following allowances to Members of the Fire and Rescue Authority (FRA) and is reviewed annually to account for any approved change in NJC for Local Authorities’ Fire and Rescue Services, Scheme of Conditions of Service (Grey Book).
